 In order to verify the compliance of the College, the Board of Governors to CCH has conducted inspection of Sophia Homocopathic Medical College & Research Institute, Gwalior, Madhya Pradesh on 25.06.2018 and furnished the recommendation as under

"Recommended for allowing admission in 1-BHMS courses with intake capacity of 60 seats for the session 2018-19 subject to removal of deficiencies reflected in the report of inspection before 31.12.2018."

After considering the provisions of section 12C (1) of Homoeopathy Central Council (Amendment) Ordinance, 2018, HCC(MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, observation of the Hearing Committee and Policy of the Central Government for granting permission during the session 2018-19, conditional permission of the Central Government is hereby granted to Sophia Homoeopathic Medical College & Research Institute, Gwalior, Madhya Pradesh for continuing admissions in existing BHMS course with intake capacity of 100 seats subject to condition that the college shall fulfill the following requirements by 31st December, 2018:

A copy of the compliance report shall be submitted by the college to CCH under intimation to this Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2019-20 and furnish the recommendation to the Central Government.
