Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy. The deficiencies observed are as follows.

- A. **Hospital facilities:** USG is not covered under MOU, USG register not provided. Functionality of USG could not ascertained
- B. **Teaching Faculty:** For Under Graduate courses, 29 Full time and 12 Guest faculty provided by college but 27 Full time and 11 Guest faculty considered eligible.
  - i. Dr. Manish kumar Rastogi, Professor (MD Ped 2019)-Joined as Professor on 11.7.20 in present college. Previous experience in POM as professor from 21.10.11 and previous

experience of lecturer is from 1.1.01 till 20.10.11 in pathology department. As previous experience of lecturer and reader is not in concerned subject so not eligible as professor n POM.

- ii. Dr.Mona Mishra, Reader (BHMS 2003)- joined as reader on 24.2.21. Previous experience of lecturer is from 4.9.2009 till 9.9.2013. As 10 years of lecturer experience not completed so not eligible as Reader.
- iii. Guest Reader, Surgery- Dr. Vidhi Sharma joined on 1.6.18. Previous full time teaching experience not provided.
- C. **College Laboratories:** Mummified bodies not available.
- D. **Library:** System of cataloguing not mentioned.
- E. **The college has not complied to few documents:**
  - i. Biometric Attendance- suspended.
  - ii. Form-16 of 9 staffs only provided.


3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, **Permission of the Medical Assessment and Rating Board is issued to Sophia Homoeopathic Medical College (Swastik Educational & Social Welfare Society's), Mahal Gaon, Opp. R.I. Training Institute, City Centre, Gwalior. Pin-474 002 for continuing admissions in 1- BHMS course with intake capacity of 100 seats in BHMS course during the academic year 2021-22. The College is directed to fulfill all the deficiencies within a period three months from the date of issue of this permission letter and an affidavit of the Controlling Officer in this regard may be submitted to the Medical Assessment and Rating Board within a period of one week.**

4. All admissions in Under Graduate shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.



**Sub: Permission letter to Sophia Homoeopathic Medical College (Swastik Educational & Social Welfare Society's), Mahal Gaon, Opp. R.I. Training Institute, City Centre, Gwalior. Madhya Pradesh with intake capacity 100 seats in undergraduate (BHMS) Course for the academic session 2022-23 – reg.**

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma and were examined by the Medical Assessment and Rating Board. Thereafter, an inspection was conducted on 14/11/22. The following shortfall were observed –

**A. Miscellaneous**

- Acquittance role is maintained without signatures on Revenue stamp.
- USG Register is not provided.

2. After considering the provisions of NCH Act, 2020 and its relevant regulations, **Permission of the Medical Assessment and Rating Board is issued to Sophia Homoeopathic Medical College (Swastik Educational & Social Welfare Society's), Mahal Gaon, Opp. R.I. Training Institute, City Centre, Gwalior. Madhya Pradesh for conducting the undergraduate (BHMS) Course with intake capacity of 100 for the academic session 2022-23.** The principal is directed to fulfill the short comings within 30 days and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week from issue of this letter

3. Regarding Post Graduation MD(Hom) course during the academic year 2021-22 MARBH has denied permission for all PG Courses in 05 Subjects namely Homeopathic Materia Medica, Repertory, Organon of Medicine, Pharmacy and Psychiatry with 09 seats in each, based on 11 deficiencies which have been addressed to you in letter of denial reference no-4-5/2021-22/NCH(MARBH)/PG (5 /4129-4134 DATED 16.12.21. However, The College has obtained permission for MD(Hom.) course through Hon'ble High Court vide order no. **CM APPL. 17662/2022-Mod. By Petition dated 08.04.2022.** 27 seats have been permitted in 04 PG disciplines with 08 seats in 'Homoeopathic Materia Medica, 06 seats in Pharmacy, 06 seats in Homoeopathic Philosophy/ Organon and 07 seats in Repertory.

4. The decision of the high court has been stayed as per order no. **LPA 319/2022& CM APPL. 22735/2022 & 22737/2022.** The College was denied permission for PG Courses during the academic year 2021-22. The Procedure for re-consideration of permission for higher courses is based on re-submission of application with relevant documents and the specified application fee as per regulation 'Establishment of New Medical College (Opening of New or Higher Course of Study or Training and Increase for Admission Capacity by a Medical College) Amendments Regulations 2016, clause 4 sub-clause 2 (b). Since such application has not been furnished college requires to re-submit the application of PG Course for the Academic Year 2022-23 Hence, the permission for PG Course, MD(Hom) for the academic year 2022-23 is denied by Medical assessment and Rating Board .

5. As per section 24 (3) of NCH Act 2020, if the College aggrieved by any decision of the Autonomous Board may prefer an appeal to the Commission against such decision within 30 days of the communication of such decision.

6. As per provisions of section 43 of the NCH Act, 2020 central Government has taken a policy decision vide letter no F.NO Y-11011/4/2022-EP-III Dated 14/10/2022 that all admissions shall be through NEET only with qualifying marks of 50 percentile. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET). Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT.

7. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.


8. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules. The college has to comply with the full requirements as per NCH Act, 2020 for conducting the course.
