MOU for Clinical Training of the Students in Surgery & Gyn. Obs.

1. This Memorandum of Understanding is being signed between Sophia Homoeopathic Medical College, City Centre Gwalior through it's Principal (party no.1) and St. Joseph Hospital, Jonagar Kheriya Modi Morar Gwalior 474006, through its Director (part no.2) for the period of two years which will come in to operation w.e.f. 01/07/2019
2. The object for this deal i.e. understanding is to provide the clinical facility in Hospital for teaching and training to the B.H.M.S. Students studying party no.1 College, hence memorandum is being executed between the parties on following terms:
  - a. Party no.1 will pay sum of rupees 10,000/- per year to party no.2 getting clinical facility for teaching and training to its students. Party no.2 will not be responsible for transportation of students.
  - b. At least 2hrs/day clinical class for batch wise students and 6 Hrs. each in two shift/day for batch wise internees will be allowed by party no.2 for clinical teaching and training.
  - c. Teaching and training should be guided by the teaching staff of party no.1 on duty M.O./Incharge of party no.2 has no responsibility unless consent be request only.
  - d. If any damage and breakage found by any student/internees, compensation should be paid by the party no.1 which will be recoverable from respective student.
  - e. The party no.2 has right to take independent action against any student for committing/breach of any discipline and decorum of the party no.2 hospital further party no.2 is obliged to inform to the party no.1 about action against student with commission of his/her guilt.
  - f. Teaching and training program completely based on C.C.H. Norms.
  - g. This memorandum of understating may be amended on the initiative of the either party by submitting a proposed amendment in writing to other part subject to agreement in writing by other party, the proposed amendment will be treated as part of this memorandum of understanding.
  - h. Both the parties have carefully gone through the above mentioned terms and conditions and are agree to execute this agreement without any pressure of influence.
