Sub: Permission letter to Sophia Homoeopathic Medical College (Swastik Educational & Social Welfare Society's), Mahal Gaon, Opp. R.I. Training Institute, City Centre, Gwalior. Madhya Pradesh with intake capacity of 45 seats for PG Course in 05 subject namely Materia Medica, Organon of Medicine, Repertory, Pharmacy and Psychiatry with 09 seats each for the academic session 2021-22 & 2022-23 – reg.

Ref: Hon'ble High Court Order No. LPA 319/2022 & CM APPLs. 22735/2022, 22737/2022 dated 01/03/2023.

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board. Thereafter, an inspection was conducted on 14/11/22.

2. Regarding Post Graduation MD(Hom) course during the academic year 2021-22 MARBH had denied permission for all PG Courses in 05 Subjects namely Homeopathic Materia Medica, Repertory, Organon of Medicine, Pharmacy and Psychiatry with 09 seats in each, based on 11 deficiencies which have been addressed to you in letter of denial reference No-4-5/2021-22/NCH(MARBH)/PG (5/4129-4134 dated 16.12.21. However, The College has obtained permission for MD(Hom.) course through Hon'ble High Court vide order No. CM APPL. 17662/2022- dated 08.04.2022. Interim relief with sanctioned for 27 seats in the 04 PG disciplines being 8 seats in 'Homoeopathic Materia Medica, 06 seats in Pharmacy, 06 seats in Homoeopathic Philosophy/ Organon and 07 seats in Repertory, has been issued for 2021-22, which was stayed by National Commission for Homoeopathy.

3. The decision of the high court was stayed as per order No. LPA 319/2022 & CM APPL. 22735/2022 & 22737/2022, since the College was denied permission for PG Courses during the academic year 2021-22. The Procedure for re-consideration of permission for higher courses is based on re-submission of application with relevant documents and the specified application fee as per regulation 'Establishment of New Medical College (Opening of New or Higher Course of Study or Training and Increase for Admission Capacity by a Medical College) Amendments Regulations 2016, clause 4 sub-clause 2 (b). Since such application has not been furnished the application of PG Courses in 05 subjects namely Homeopathic Materia Medica, Repertory, Organon of Medicine, Pharmacy and Psychiatry with 09 seats in each. Hence, the permission for PG Course, MD (Hom) for the academic year 2022-23 was also denied by MARBH.

4. This has reference to the court order from Hon'ble High Court of Delhi vide order dated 01/03/2023, against the decision letter passed by Ministry of AYUSH vide letter No. R-14015/2/2020/EP-II, dated 22/03/2022 & R-14015/2/2020-EP-II dated 03/02/2023 denying permission for student intake for 45 seats for PG Course in 05 subject namely Materia Medica, Organon of Medicine, Repertory, Pharmacy and Psychiatry with 09 seats each in Sophia Homoeopathic Medical College (Swastik Educational & Social Welfare Society's), Mahal Gaon, Opp. R.I. Training Institute, City Centre, Gwalior. Madhya Pradesh during AY 2021-22 & 2022-23 respectively. The matter is remanded back to the National Commission for Homoeopathy to pass a fresh order in accordance with law for the academic years 2021-22 & 2022-23 within a period of 10 days.

5. Medical Assessment and Rating Board for Homoeopathy (MARBH) has examined the entire documents submitted by the college and it has been decided that considering the available faculty positions approved by the university in the college, PG Seats for 04 subjects such as Materia Medica (04 seats), Organon of Medicine (03 seats), Repertory (01 seats), Pharmacy (03 seats) and Psychiatry (No seats) have been sanctioned for the academic years 2021-22 & 2022-23. As deficiency related to teaching faculty are still persisting are as follows:


- a) Only one faculty as Lecturer in department of Repertory is available as Dr. Mona Mishra, joined as Reader on 24.02.2021. Previous experience of Lecturer is from 04.09.2009 till 09.09.2013. She has completed BHMS in 2003. As experience of 10 years of Lecturer not completed so not eligible as Reader as per MSE 2002.
- b) No faculty in the department of Psychiatry as Dr. Shyam Sundar Prasad has experience in Organon department from 1991 and transferred to psychiatry department as Professor in 2021. As previous experience of Lecturer and Reader is not in concerned subject so not eligible as Professor in Organon.
- c) The college is directed to submit the university approved PG and UG faculty list.
- d) The continuance of affiliation certificate from the university for last academic year has not been provided.
- e) No Professor is available in the PG department of Organon of Medicine, Repertory and Pharmacy.
- f) No Reader is posted in department of Materia Medica.

The college shall fulfil all the above mention shortfalls within the period of 30 days failing which the permission issue will be withdrawn without further notice.

6. As per provisions of section 43 of the NCH Act,2020 central Government has taken a policy decision vide letter no F.NO Y-11011/4/2022-EP-III Dated 14/10/2022 that all admissions shall be through AIAPGET only with qualifying marks of 50 percentile. Any admissions carried out other than AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT.

7. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules. The college has to comply with the full requirements as per NCH Act,2020 for conducting the course.


